<b>About Mercy:</b>	MCC provides complete primary healthcare for children from birth to 18 years of age. There is a special emphasis on providing care for children without health insurance or enrolled in TennCare.  The mission of Mercy Children's Clinic is, <i>"To reflect the love and compassion of Jesus Christ by providing complete primary healthcare to children from all socio-economic backgrounds throughout Middle Tennessee."</i>
<b>Since 1999:</b>	First patient seen, November 1, 1999. Since 1999, over 6,500 children served resulting in 50,000+ patient visits.
<b>Service Area:</b>	24 Middle TN counties. Majority of patients from Williamson, Davidson, Maury, and Rutherford counties.
